- Failure to provide complete and correct information will automatically void application and forfeit application fees.
- An application must be completed for each individual soliciting.
- Each Application submitted requires a \$75.00 application fee. Application fee must be in the form of Check or Money Order, payable to the Town of Homecroft, and mailed in with the application.
- Solicitation may only occur between 9:00 AM EST and Sunset.
- Copy of Solicitor's Valid Driver's License or State Issued Photo ID must be mailed in with Application and Fee.
- Copy of Business or Commercial License must be mailed in with Application and Fee. Title IV of the Revised Code of the Consolidated City and County of Indianapolis mandates that Solicitor must have copy of business/commercial license
- If Applicant is an American Disabled Veteran, applicant may send in copy of proof of status and have the \$75 application fee waived. Proof of Status or Fee must accompany application.
