- c. Action Item: At the Town Boards discretion, refund \$12,701 to the MVH fund from the GEN fund for fuel disbursements above the allowable limit for 2013 thru 2015. A motion to transfer funds from the GEN fund to the MVH fund was made by Mr. Eickhoff; motion was seconded by Mrs. Fleck. The motion carried. (Completed on 5/31/2017)
- 4. Approval by the Town Board for the use of a procurement card issued by Chase Bank to Chief Ryan and Clerk/Treasurer Kevin Kehlbeck. The expenditures incurred will be approved by the board along with the other claims as usual. A motion to approve use of the procurement card was made by Mr. Eickhoff; motion was seconded by Mr. Frizzell. The motion carried.
