Funds have been paid to VS Engineering to commence the sign project. Mr. Hanson will provide a copy of the cancelled check to provide with this project. Letting for the project should be in December 2014.

Special Projects Report – Mr. Frizzell has been monitoring the web site and has been meeting with GSBA with some of their projects.

Police Department Report – National Night Out is still on track with the assistance of Laurie Layton. All is quiet in the town. C.T. Bowman was present as acting Police Chief. Mr. Eickhoff motioned to have Mr. Ryan procure the form that is being required by the Trustee’s office for the officers and all others that would have keys and key fob’s and their assignment for access to the building and to compile this information. Tim will then provide copies of this Document to the Trustee. Mr. Mosier seconded the motion. The motion carried. Also Mr. Eickhoff made a motion to allow Laurie Layton the discretion

to purchase two hundred dollars' worth of gift cards for NNO. Mr. Mosier seconded the motion. The motion carried.

Other Old/New Business- Kyle read a letter from Mr. Carney who is running for Marion County Sheriff thanking Homecroft for allowing him to address the Town Council.

Mr. Hanson offered praise for the Homecroft Picnic that was held in Laurel Indiana and thanked Sam Lowe for his offer to hold this event on his uncle's property there. It was a great way to gather our officers and family together.
