*Public Works Report* – Mr. Mosier had a notice from a homeowner on the storm sewers with Mr. Clem with the City of Indianapolis.

Chris will forward this notice to Mr. Sandlin with the city. There were some trees that were trimmed and code enforcement did issue a citation to one homeowner because of low hanging branches.

The town should be able to get reimbursement of the engineering costs that have been paid out. We will look for November/December letting for the upcoming project. February or March roll out of the sign project.

*Special Projects Report* – Mr. Frizzell had a notice that was presented on “Next Door” and brought that to the board. The newsletter was distributed this last month.

*Police Department Report* – Mr. Eickhoff brought forward a request for Halloween items to give out to the Trick or Treat evening. They requested more glow sticks and less candy. Tim made a request to go to \$400 for this event. It was seconded by Mr. Frizzell. The motion carried.

The Hathaway running event went well this last week.

Tim motioned to increase the pay of Chief Ryan. This will be discussed at October's meeting with a possible increase in next year's budget. Mr. Joseph will see if we may have an executive session on this possible change.

***Other Old/New Business-*** Kyle did get in mail a notice about the development on Stevens drive. The board will not take a position. We will begin sending our citations over to the Beech Grove courts and have them process these tickets. Mr. Eickhoff motioned to start this process. Mr. Mosier seconded the motion. The motion carried.
