*Special Projects Report* –Mr. Frizzell ask for us to renew our website contracting for two years for \$79.00 to extend the platform for the site. Zack made the motion, Mr. Eickhoff seconded the motion. The motion carried.

*Police Department Report* – Lucas Quinlin has joined our police force. He is formerly from the Southport Police Department.

In preparation for our Police appreciation dinner  $250 \times 15 = 3,750$  for Gift card was the amount that was given to the officers last year and this will be the amount given to the officers this year.
