Special Projects Report – Mr. Frizzell spoke of the meeting several of us attended concerning the development on Homecroft Elementary and the 50 million dollar referendum with the Perry Township school board. The City of Southport invited us to be in the 4th of July parade. There was a Bond for the Council President that was not properly completed and will need to be amended. Mr. Hanson will contact the Bonding Company to get this corrected.
