July 2021 Homecroft Town Council Police Liaison Briefing

The new Durango's have still not been put into service yet, as they continue to await for items at the up fitting vendor, and parts for radio equipment. The Chief is exploring alternatives for quicker up fitting if he decides to change course from the current vendor. I have asked the Chief for a fleet report so we can analyze and plan our future needs; he is working on creating that report.

National Night Out planning continues; the Chief reports that donations are down and that they might go over budget by an undetermined amount. He will continue to monitor.

There was a daytime disturbance that ended up in the parking lot of the Police Department/Town Hall recently and was handled by the Perry Township School Police. The incident originated at the Hobby Lobby. PTSP made an arrest for operating while a habitual traffic violator, criminal recklessness, and resisting law enforcement. We thank them for their assistance.

The 6800 block of Madison Avenue continues to have a resident that is generating some police run activity; the camper that was in the driveway is now gone, but some police runs to the address continue.

July 2021 training was conducted by IMPD Officer Curtis Johnson and consisted of field sobriety training and a wet lab. The detailed training was well received by the officers and provided a hands-on and realistic scenario to see first-hand the effects of alcohol and how various levels of impairment correspond to clues for each type of field test.

August 2021 training will be at the Hancock County range, and will consist of rifle, shotgun, and handgun practice.

Chief Leonard has announced promotions consisting of moving Dave Hodge to Assistant Chief, Jason Holland to Major, Jeff Dunn to Lieutenant, and Matthew Baker to Sergeant. Badge pinning for those promotions will occur at the July 2021 Town Council Meeting.
