

Ordinance No. 16-03

**TOWN OF HOMECROFT GENERAL ORDINANCE**

**A GENERAL ORDINANCE** amending the Code of Town Ordinances for the Town of Homecroft, Article 3, Chapter 2, Section 9 and Section 10 and General Ordinance Nos. 87-3-1 and 87-3-2 regarding Parking on certain streets within the Town of Homecroft.

**WHEREAS**, the Town Council of the Town of Homecroft now determines it to be in the best interest of the Town to prohibit parking along the South side of any east west street within the Town, and

**WHEREAS**, the Town Council of the Town of Homecroft now determines it to be in the best interest of the Town to prohibit parking along both the East and West sides of any north south street within the Town, and

**WHEREAS**, the Town Council of the Town of Homecroft now determines it to be in the best interests of the Town to amend the Municipal Code to increase the fines set out in Article 3, Chapter 2, Section 9 for parking violations, and

**WHEREAS**, to accomplish such prohibited parking designation the Code of Town Ordinances, Article 3 (motor Vehicle Regulations), Chapter 2 (Parking), Section 1 (Prohibited Locations) should be amended to delete current subsections C, D, E, F and G in their entirety and to add a new subsection C, D, E, F, G, H, I, J, K, L, M, N, and O to prohibit parking along the South side of any east west street within the Town and a new subsection D to prohibit parking along the East and West side of any north south street within the Town, and

**NOW THEREFORE, IT IS HEREBY ORDAINED BY THE HOMECROFT TOWN COUNCIL THAT:**

1. That the Code of Town Ordinances of the Town of Homecroft shall be amended as follows:

Article 3: Motor Vehicle Regulations  
Chapter 2: Parking  
Section 1: Parking shall be prohibited at all of the following locations at all times:

Current subsections C, D, E, F and G of Article 3, Chapter 2, Section 1, are deleted in their entirety.

New subsections C, D, E, F, G, H, I, J, K, L, M and N are added to Article 3, Chapter 2, Section 1, as follows:

- C. On or along the south side of Banta Road from its intersection with Homestead Drive on the east to its intersection with Orinoco Avenue on the west.
- D. On or along the south side of Loretta Drive from its intersection with Homestead Drive to its intersection with Shelby Street on the west.
- E. On or along the south side of Maynard Road from its intersection with Homestead Drive on the east to its intersection with Shelby Street on the west.
- F. On or along the south side of Southview Drive from its intersection with Homestead Drive on the east to its intersection with Shelby Street on the west.
- G. On or along the south side of Tulip Drive from its intersection with Homestead Drive on the east to its intersection with Shelby Street on the west.
- H. On or along the entire south side of S. Court Drive from its intersection with Orinoco Avenue on the east to the end of S. Court Drive on the west.
- I. On or along the entire east side and west side of Shelby Street from its intersection with Southview Drive on the south to its intersection with Loretta Drive on the north.
- J. On or along the entire east side and west side of Shelby Court from its intersection with Loretta Drive on the north to the end of Shelby Court on the south.
- K. On or along the east side of Orinoco Avenue from its intersection with Southview Drive on the south to its intersection with Banta Road on the north and on or along the west side of Orinoco Avenue from its intersection with Southview Drive on the south to its intersection with Loretta Drive on the north.
- L. On or along the entire east side and west side of Dresden Street from its intersection with Southview Drive on the south to its intersection with Banta Drive on the north.

M. On or along the entire east side and west side of Madison Avenue between Tulip Drive on the south and Banta Road on the north.

N. On or along the entire east side and west side of Homestead Drive between Tulip Drive on the south to Banta Avenue on the north.

2. That the Code of Town Ordinances of the Town of Homecroft shall be amended as follows:

Article 3: Motor Vehicle Regulations

Chapter 2: Parking

Section 9: Current Section 9 of Article 3, Chapter 2 is deleted in its entirety.

New Section 9 is added to Article 3, Chapter 2, as follows:

Section 9: Any person found in violation of any provision of this chapter shall be fined the sum of twenty dollars (\$20.00) for each violation if the fine is paid within ten (10) days of the date of the violation. If the fine is not paid within ten (10) days of the date of the violation then the fine shall increase to forty (\$40.00) for each violation. If the fine is not then paid within twenty (20) days of the date of the violation then the fine shall increase to sixty (\$60.00) per violation plus the costs of any collection action including, but not limited to, court costs.”

3. That Homecroft General Ordinances 87-3-1 and 87-3-1 are hereby repealed in their entirety.

4. The expressed or implied repeal or amendment by this ordinance of any other ordinance, or part of any other ordinance does not affect any rights or liabilities accrued, penalties incurred, or proceedings begun prior to the effective date of this ordinance. Those rights, liabilities, and proceedings are continued, and penalties shall be imposed and enforced under the repealed or amended ordinances as of this ordinance had not been adopted.

5. Should any provision (section, paragraph, sentence, clause, or any other portion) of this ordinance be declared by a court of competent jurisdiction and to be invalid for any reason, the remaining provision or provisions shall not be affected, if and only if such remaining provisions can, without the invalid provision or provisions, be given the effect intended by the Council in adopting this ordinance. To this end the provisions of this ordinance are severable.

6. This ordinance shall be in effect from an after its passage by the Council and

compliance with Indiana code 36-5-2-10.

This Ordinance is hereby adopted at the duly noticed and regularly scheduled meeting of the Homecroft Town Council held this 25 day of August 2016.
