



The Madison and Loretta Project is expected to start in the middle of June and last approximately 3 weeks. The intersection of Madison and Loretta will remain open as much as possible, especially in the evenings and over the weekends. The town will be notified about a week or two before the construction will begin so that we have a more firm start date.

Missing street signs at Maynard and Shelby, as well as Madison and Tulip, have been replaced. Chris should be out to clean the gutters along the curbs in the next few weeks.

DPW has been working on the sidewalk ramps along Loretta between Orinoco and Shelby. I am trying to find out more information about this project, especially since the work paused this week and because we are hoping that they might address the drainage issues at Shelby and Loretta while they are working in the area.

**Police Liaison Report to the Homecroft Town Council  
April 2023 Report for the May 25, 2023 Council Meeting**

Dear Fellow Council Members et al:

17 members of the Homecroft Police Department contributed 530 cumulative hours protecting and serving the residents and visitors of Homecroft in March 2023.

While patrolling 3,803 miles, officers wrote 89 town ordinance tickets and issued 86 warning citations. Their enforcement efforts resulted in 13 vehicles being towed. They oversaw 52 total calls for service and assisted with 87 other calls for service. Most of these services calls were agency assist runs helping the Indianapolis Metropolitan Police Department with calls in the vicinity of town.

New Officer Mason Hadley is in 40-hour pre-basic training. Body Cameras have been ordered and are expected to be received around the 2<sup>nd</sup> week of June 2023. The computer to download video and process video requests has been ordered. The new (refurbished) tasers that will cooperatively work with our body cameras have come in.

*We must steadfastly continue to be vigilant, highly visible, leverage available technologies, strengthen partnerships, and prepare our officers with the best training & equipment possible to respond to and abate violence in and near our town.*
